As promised in the initial issue of the newsletter, the following information will help explain the funding of the Fire District and some of the issues we face.

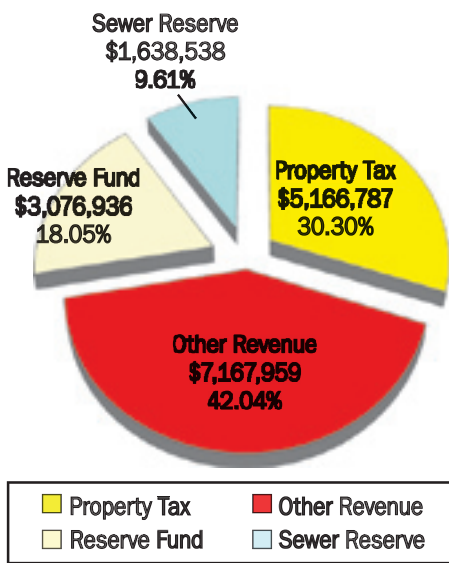
Real Property Tax

Aside from a few grants and some small donations, the real property tax is the only source of Fire District revenue. The Fire District receives 99.44% of its revenue from the real property tax. This is in contrast for example, with the Town of Henrietta which receives only 30.303% of its revenue from the real property tax. The rest of the Town's revenue comes from other taxes such as the sales, hotel/motel and mortgage tax together with fees for service as well as reimbursement from the State for such things as snowplowing for State roads.

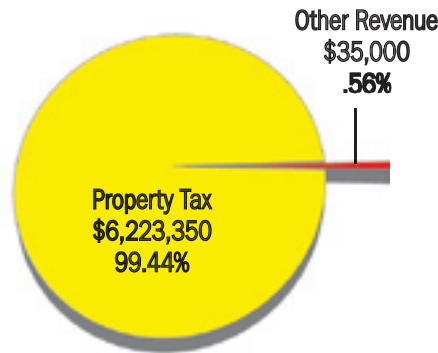
To put that in perspective, if the Fire District received only 30.303% of its revenue from the real property tax, the fire tax would be 62 ¢ per thousand. In an effort to minimize the impact on taxpayers, the Fire District has postponed some programs and purchases, sought grants whenever possible and pursued other funding initiatives.

This is not intended as a criticism of the Town's revenue sources, but to explain how different the funding mechanisms are for the Town and the Fire District, despite the fact that we have the same boundaries and serve the same number of people, residences, businesses, schools, etc.

Grants

We constantly seek grants for the Fire District. Grants are not always listed in the annual budget because they are announced and awarded throughout the year and have separate spending requirements. We can only list guaranteed funding sources when the budget is prepared and adopted. Some require spending the grant money within a few months of the grant award. Others may allow a year or more for spending the grant funds and these can be listed in upcoming budgets.

We make every effort to obtain grants, but there is very limited grant money available to the fire service and we compete for these funds with the rest of the fire service. Between 2001 and 2008 we have been awarded 8 grants totaling \$450,579.00. With this grant money we have purchased:

- Confined space equipment
- Radio equipment
- Firefighter turn out clothing
- Breathing apparatus equipment upgrades
- Exhaust extrication systems for our apparatus
- Backup generators for the fire stations
- Thermal imaging cameras to aid in search and rescue

The grants do not always cover the full cost of these purchases and we must make up the difference from other operating funds.

Other Initiatives

We have had some success with cooperative bidding with other Fire Districts with equipment purchases to reduce costs. Most recently, we made a cooperative purchase of fire hose with the Rush and Mendon Fire Districts at a reduced cost.

We have also tried to be creative in reducing costs and increasing revenue sources, but so far have been unsuccessful. We proposed an incentive based savings suggestion program which would pay 10% of the first year's savings to whomever made the suggestion. If there was no savings, there would be no payment. The second through fifth years, the savings award would be reduced by 2% each year. This was a no cost program however, the State Comptroller said we could not institute such a program as it would be a gift of public funds despite the fact that the savings was to be the source of the incentive payment.

Donations

The three volunteer fire companies solicit donations but the Fire District does not. We occasionally receive modest, unsolicited donations, which are used to further our Fire Prevention Programs.

Tax Exempt Property

The total assessed value of all taxable property in the Henrietta Fire District is \$3,089,519,329.00*.

18% of the property in the Henrietta Fire District is tax exempt and carries an assessed value of \$678,427,279.00*. The payment of the Fire Tax partially subsidizes these tax exempt properties.

The R.I.T. Impact

56.27% of tax exempt property value in the Henrietta Fire District is owned by R.I.T. It has an assessed value of \$381,784,000.00*. The net effect of these exemptions is that 22.52¢ (11%) of the \$2.04 Fire Tax subsidizes the R.I.T. exempt properties. That would mean a house assessed for \$100,000 would pay a

\$22.52 subsidy in 2010.

R.I.T. currently makes a voluntary contribution of \$35,000 to the Fire District. That is what a property assessed for \$17,094,050 would pay in Fire District Taxes in 2010, which is 4.47% of their total tax exempt property value.

The Henrietta Fire District responded to 3,633 incidents in 2009, 16.76% or 609 of these incidents were to R.I.T. facilities. We also provide Fire Safety programs, fire extinguisher training, D.W.I. extrication demonstrations, as well as other services to R.I.T. students, faculty and staff.

R.I.T. has made changes to their alarms systems to reduce avoidable alarms, but we see little change in the overall number of alarm responses. While on campus responses have decreased, alarm responses have now shifted to new housing on adjacent properties. They are cited for avoidable alarms and pay fines for certain avoidable alarms. These fines are paid to the Town of Henrietta, not to the Henrietta Fire District.

What Other Colleges And Universities Do

Cornell University makes a payment of approximately \$1,000,000 each year to the City of Ithaca, NY for public safety services.

"Each year, Yale University pays the City of New Haven more than \$10 million in taxes, voluntary payments, and fees - money that helps fund schools, safety, and other citizen services"**.

"Providence's (R.I.) four private schools -- Brown, Providence College, Johnson & Wales University and the Rhode Island School of Design -- agreed in 2003 to pay the city nearly \$50 million over 20 years"***. Providence Mayor David Cicilline is currently seeking to assess a fee on each of the 25,000 full time students.

Who's Who at the Henrietta Fire District

Ryan Barber Lieutenant

Ryan Barber comes from a long line of firefighters. His Great Grandfather and Grandfather were volunteer firefighters with the West Brighton Fire Dept. His father Ron, is a Battalion Chief with the Henrietta Fire District, where Ryan is also a volunteer firefighter running out of Company #1.

Ryan's older brother Doug is a career firefighter with Henrietta. Ryan started as a Fire Explorer when he was 14 then joined as a firefighter in 2004 when he turned 18. He graduated from Rush Henrietta High School, then earned an associates degree in Fire Protection Technology from Monroe Community College.

Currently, Ryan is a Lieutenant, and once or twice a week, participates with the evening bunk in crew at Company #1. The bunk in crew is made up of volunteers who are on duty at one of the stations at various times during the overnight hours. This is not mandatory, but provides outstanding service to the community by drastically reducing response times.

When not volunteering his time for the Henrietta Fire Dist., he works full time as an emergency medical technician for Brighton Ambulance. He also works part-time for Henrietta and Spencerport Ambulance. Ryan is a newlywed, who's wife Margaret is a paramedic and physician's assistant. Ryan states that he met his wife while volunteering with the Henrietta Fire District.



Tom Hayes Career Firefighter

Tom Hayes grew up in Henrietta watching his Dad go to work as a firefighter at the Rochester Airport. Now, with a family of his own, he heads out the door as a firefighter with the Henrietta Fire District. In 1998 Tom joined the Henrietta Fire District as a volunteer at Company #2. He continued his education at

MCC earning an Associates degree in Fire Science Technology. Tom was hired as a career firefighter in 2002 and works out of Station #4 on Bailey Rd.

Many of you may know or see him around town as Tom is also an Eagle Scout, a lifeguard at Riverton, and a part time bus driver for the Rush-Henrietta School district. Muscular Dystrophy Association

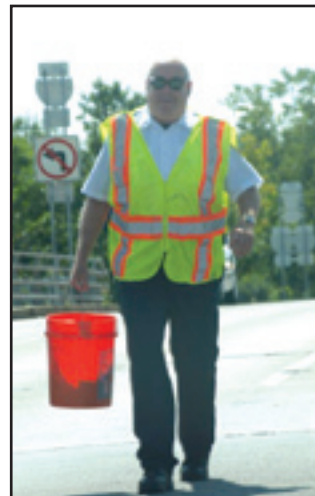

Adopt-A-Hydrant Program

The Henrietta Fire District offers the Adopt-A-Hydrant program to all Third, Fourth, and Fifth grade students at all Rush-Henrietta Elementary schools. We ask the children (or family) to "Adopt" a fire hydrant. The children are asked to keep the fire hydrant accessible for the fire department by cleaning weeds and debris from around the hydrant, and keeping it clear of snow in the winter time.

We hope this program will increase awareness of the important role that fire hydrants play in the protection of their homes and additionally foster civic participation in the children.

The children fill out an adoption form and return it to school. The Henrietta Fire District will then issue an "Adoption Certificate" with the child's name and hydrant location on it. In addition to the certificate, one participating child from each school is chosen for a special ride to school in a fire truck.

Fire Prevention and Safety

New Fire Apparatus

The Henrietta Fire District has taken delivery of 3 new Emergency One (E-One) Rescue Pumpers. They will be assigned to Station #1 at 3129 E. Henrietta Rd., Station #3 at 9 Riverview Dr. and Station #5 at 230 Pinnacle Rd. Two of the apparatus being replaced were 23 years old and the third was 33 years old. The new Rescue Pumpers are identical, which allows for the simplification of parts supply and reduces parts inventory. This purchase updates our apparatus replacement program.

The new apparatus meets or exceeds all current standards. They are equipped with latest safety features such as, a Stability Control System, Automatic Traction Control and a Vehicle Data Recording System, which is similar to an airplane's "Black Box". By purchasing these pumpers in 2010 the District save for an estimated saving of \$45,000. In 2011, additional mandated pollution controls would have added approximately \$15,000 per truck.

Smoke Alarms: Up, Down and All Around

In an effort to better educate communities throughout the U.S. about smoke alarm recommendations, the nonprofit National Fire Protection Association (NFPA) is promoting "Smoke Alarms: A Sound You Can Live With!" as the theme for this year's Fire Prevention Week campaign, October 3-9, which The Henrietta Fire District is supporting locally. NFPA has been the official sponsor of Fire Prevention Week for 88 years.

Smoke alarms can mean the difference between life and death in a fire. NFPA statistics show that working smoke alarms cut the chance of dying in a fire nearly in half, but they must be working properly to do so. The association's data shows that many homes have smoke alarms that aren't working or maintained properly, usually because of missing, disconnected or dead batteries. Roughly two-thirds of all home fire deaths result from fires in homes with no smoke alarms or no working smoke alarms.

NFPA and the Henrietta Fire District agree that interconnected smoke alarms offer the best protection; when one sounds, they all do. This is particularly important in larger or multi-story homes, where the sound from distant smoke alarms may be reduced to the point that it may not be loud enough to provide proper warning, especially for sleeping individuals.

The Henrietta Fire District offers the following tips for making sure smoke alarms are maintained and working properly:

- Test smoke alarms at least once a month using the test button, and make sure everyone in your home knows their sound.
- If an alarm "chirps," warning the battery is low, replace the battery right away.
- Replace all smoke alarms, including alarms that use 10-year batteries and hard-wired alarms, when they're 10 years old (or sooner) if they do not respond properly when tested.
- Never remove or disable a smoke alarm.
- Change your batteries twice a year. Change them when you change your clocks for day light savings.
